

**TOWNSHIP OF LUMBERTON, NEW JERSEY**

**ORDINANCE NO. 2017-005**

**AN ORDINANCE OF THE TOWNSHIP OF LUMBERTON,  
IN THE COUNTY OF BURLINGTON, NEW JERSEY,  
APPROPRIATING CERTAIN MONIES FROM THE  
CAPITAL ACCOUNT AND PROVIDING FOR VARIOUS  
CAPITAL IMPROVEMENTS AND RELATED EXPENSES  
IN AND FOR THE TOWNSHIP**

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF LUMBERTON, IN THE COUNTY OF BURLINGTON, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

**Section 1.** From the Township’s Capital Surplus Account, there is hereby appropriated the sum of \$27,000 for the following purposes:

<b>PURPOSE</b>	<b>APPROPRIATION</b>
Purchase of 2 Replacement Mason Dump Truck Bodies for vehicles within the Public Work’s Department	<b>\$18,000</b>
Purchase of Various Police Department Equipment, to include but not be limited to the purchase of two (2) body worn cameras and docking stations, along with two (2) Taser Guns equipped with camera and 5 year warranty	<b>\$9,000</b>
<b>TOTALS</b>	<b>\$27,000</b>

**Section 3.** The capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing in full detail the amended capital budget and capital improvement program as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, are on file with the Clerk of the Township and available for public inspection.

**Section 4.** This ordinance shall take effect twenty (20) days after the first publication thereof after final adoption as provided by the Local Bond Law.
