COMMENTS FROM THE PUBLIC

Ray Christenson, 1 Oak Landing Road, what is the cost of the playground fix? Committeeman Conway stated the cost to the Township will be \$500.00. Mr. Christenson will cover the cost.

Mount Holly Resident, had questions for the Committee regarding flood damage. He also asked if the Township has an Economic Committee. The gentlemen inquired about the location of the Memorial Day Parade.

COMMENTS FROM THE COMMITTEE

Committeeman Dinneen spoke about the Memorial Day Parade on Monday at 1pm on Main Street.

Mayor Jackson is not happy with some of the media coverage about our Town. A video was posted on the web, involving Officer Paul Craig, who was hired and paid by the group holding the meeting. The reporter attempted to enter the building and got into a discussion with Officer Craig, who handled himself with professionalism. The reporter made comments regarding public officials in attendance at the meeting; there were NO public officials in attendance. The only person who would have been a public official would have been the Fire Marshall, who would be making sure the location did not exceed the occupancy allowed. Reporters may want to create an issue, create a story that's not there, try to create controversy to sell newspapers; they are perfectly free to do that. As long as I have a microphone I will call them out on it.

Committeeman Conway added that the mentioned reporter is our Township reporter, who has only been to one Township Meeting.
