Upon assessing the female, he determined that she was unresponsive due to a narcotics overdose. Patrolman Cheesman administered Narcan to the female who then regained consciousness. She was taken to Virtua Hospital in Mount Holly where she is expected to make a full recovery.

This is the third Narcan save for the Lumberton Police Department, since the inception of the Narcan Program as of July 1, 2014.
