The Township Committee thanked the Lumberton Fire Department and all those who responded. Tender Engine 1314 was special called and was assigned to assist in the Alpha pipeline. After dropping all 1,000 feet of 5 inch hose, it set up to 2 feed 2 ladders. 1314 pumped for about 10 hours before being changed out to assist with the tender water shuttle. There 1314 dropped 15 loads of water into the portable ponds. The truck travel approx 250 miles throughout the duration of the assignment. Some of the obstacles that were faced was a major air leak which Bob the twp mechanic was called to come out and fix the same. Bob made the repair to the truck without having to shut down the operation. The second was a radio issue and George and John Swain responded to make a temporary repair to keep the communication possible. Around 5 am today Captain Pearson contacted me, to let me know they had been released and they were in need of assistance with repacking the 5 inch hose. A crew was put together and the truck was restored by 7 am. Again it was great team work from everyone in the response, getting the job done which we were assigned, handling issues, getting food and drink there to our members, and the restoration of our apparatus.

Other responses that we were called for was the Fire Police were 1318 and they spent several hours assisting with traffic flow.

Foam Task Force B were 1317 and the foam trailer responded and were later recalled. 1319 as part of several cascade trucks dispatched were that sat in staging for several hours and were recalled.

The Mayor received correspondence from a resident regarding a concern for the speed limit on Bridge Road. Bridge Road is property of the County, the Police will look into the traffic concern and advise accordingly.
