## DEPARTMENT HEAD REPORTS

#### COURT

Committeeman Dinneen stated that the Court continues to do a good job for collecting court fee and Mayor Jackson stated that he was able to observe yesterday's court session and noted how the court was being run.

### ADMINISTRATORS REPORT

Mr. Umba reported that the Township will be going out to a BAN Sale in the month of August to cover the three capital ordinances that are not funded currently, the third quarter collection rate as of this evening stands at 92.6% and all tax payments have been made to the County and Schools.

The line striping project is ready to go to the vendor to be executed with the reports being submitted by Lt. Begolly and Mr. Shover. Mr. Umba asked for approval for him to move forward with the Street Lining Project, on a motion by Committeeman Conway seconded by Committeeman Dinneen and carried by unanimous favorable voice roll call vote, the Township Committee gave approval to move forward with the project.

August 25, 2015

Mayor Jackson asked for a progress report on the PSE&G Bella Road project. He was informed by Committeeman Conway that PSE&G is still actively working in the area and road improvements will take place once they are completed to repair the damage to the street. Mr. Umba will insure that Public Works has patched the current pot holes in the meantime.

Mr. Umba stated that the radar on Bobby's Run Blvd has been looked at by the vendor who originally installed it which is R and R Radar and that radar was being repaired with the second radar being sent to its shop for a free estimate on its repair.

Mr. Umba reported on several other items in his report and asked for any questions from the Committee. No additional questions were asked.

### **OLD BUSINESS**

Mr. Umba gave an update on the installation of the windows at the Guan Building.

Committeeman Mansdoerfer, requested that with HVAC work raping up that the Township go out for a Bid for a maintenance contract for the system. Mr. Umba stated that he would investigate the matter and provide a recommendation.

Mr. Umba requested approval of a project fee estimate from CME dated January 29, 2015 for work to be performed at the site of the old Municipal Building to conduct professional land surveying and base mapping services for a proposed Emergency Services Building. On motion by Committeeman Mansdoerfer, seconded by Committeeman Conway and carried by unanimous favorable voice roll call vote with an abstention from Committeeman Conway, the Township Committee approved the project fee estimate.

### **NEW BUSINESS**

Committeeman Mansdoerfer reported that the Fire Department was in need of a overhead door replacement. Mr. Umba stated that he would look into the matter with the Fire Department to have it resolved.

Mr. Umba gave an update on two proposals from Pennoni Assoc., one being for Allspice Phase 2 and the other being the intersections. Committeeman Conway stated that it might be favorable to bid both of projects together in the fall for work to be performed by Spring 2016.

Mr. Umba gave an update on an additional proposal from Pennoni Assoc. regarding the Village Green Phase 2 Well Installation project, which was tabled for further discussion.

Committeeman Conway also stated that our DEP reviewer on the Boat Ramp Project passed away and that we will be assigning a new staffer.

Mayor Jackson commented that Deputy Mayor Earlen attended an Eagle Scout Court of Honor on behalf of the Township.

Committeeman Dinneen stated that the Lumberton Youth Association Opening Night will be September 11, 2015 and we are expecting a great year for the LYA this year. He welcomed Robin Sarlo the Township's new CFO and thanked the Township Engineer for overseeing the demolition of the former Municipal Complex
