# 6) ADMINISTRATOR'S REPORT:

Administrator Umba presented his report as written and asked for any comments from the Township Committee. Mr. Umba highlighted his recommendation to install benches at the playground areas for the parents accompanying children to utilize as there are project funds available. The Committee authorized Administrator Umba to proceed with procuring quotes for the benches similar to such at the dog park.

# 7) OLD BUSINESS:

Administrator Umba noted the Maple Grove Boulevard project will commence as soon as Governor Christie lifts the stop work order as all involved are prepared to begin. Mayor Earlen reiterated for the record that the Township Engineer recommended this road as the highest priority for repair.

Mr. Umba reported the Newbolds Corner Road project was inspected by the Township Engineer who provided a punch list to Arawak Paving.

Mr. Umba confirmed the Allspice Road project inspections are being performed to determine the project was completed in compliance with the contract specifications in order to release the performance bond and activate the maintenance bond.

## 8) **NEW BUSINESS**:

Township Committee requested that Mr. Umba investigate and seek additional confirmation regarding the submission of TAP grant application.

Administrator Umba reported proposals were received in compliance with competitive pricing requirements for the inspection and certification of FEMA projects with the lowest being submitted by Pennoni Associates. Township Committee agreed with Administrator Umba recommendation to award Pennoni Associates the contract to inspect and certify each FEMA project for compliance to FEMA requirements for reimbursement.

Mr. Umba disclosed that a PSEG paving repair project is slated to begin within the next few weeks and he will provide status updates to Committee and notice to residents.

Administrator Umba reviewed the CY2016 Best Practices Inventory prepared by CFO Sarlo for submission to the DLGS with all members of the Committee noting the following points:

- a.) Lumberton Township exceeded the minimum 80% compliance rate by scoring 90% compliance rate resulting in no loss of State Aid
- b.) Several questions on the inventory worksheet do not apply to Lumberton Township due to the size of the Township, limited employee count and other factors outside our control
- c.) Lumberton Township will continue to strive to achieve a 100% compliance rate

Township Committee discussed the Land Use code regarding housing chickens and authorized Administrator Umba to investigate the surrounding communities' typical zoning and/or variance requirements for lot size, maximum number of animals, and effect on community for further consideration prior to rendering any determination of violations.

### **COMMENTS FROM THE TOWNSHIP COMMITTEE:**

Committeeman Mansdoerfer expressed appreciation for the efforts and contributions of the Lumberton Township Fire, EMS and Police Departments in making the Fire Prevention event successful.

Committeeman Dinneen thanked the administrative staff and professionals for the timely completion of the playground projects. He also thanked the Fire Department for visiting the schools to encourage fire prevention and commended Police Chief DiLoreto for the promotion of body cams.

Mayor Earlen remarked that the Turnbridge playground project was an example of successful community activism by residents petitioning the Committee to prioritize rehabilitating that park and thanked them for their commitment to their community. He also revealed he received a call complimenting the great job on the road paving at Newbolds Corner Road and accolades on the opening of the boat launch.

Mayor Earlen recognized resident Bill Curtin for facilitating the idea that Lumberton Township consider community support and aid to the hurricane Matthew victims in Lumberton, NC as they were so kind to provide to this community after hurricane Sandy in 2004. All Township Committee members agreed a donation/aid effort is a great suggestion and authorized Administrator Umba to post messages on the website and social media with Lt. Begolly to provide the list of items needed to the community and schools.

Committeeman Mansdoerfer acknowledged Police Chief DiLoreto for continuing his training and education by attending the Police Chief's Conference next week.

Solicitor Morris reminded the residents that the "Support Relay for Life" will be held on Friday, October 14, 2016 from 6PM through 12AM. This event raises funds for cancer research and awareness.
