Mr. Umba made the Township Committee aware that the vendor for Fostertown Road has acknowledged the seam in the road and will be out to repair. Committeeman Mansdoerfer update the Township Committee that a draft of the new Public Safety Building is prepared and ready for input from the Fire, EMS, OEM and Fire Inspectors.
