# INTRODUCTION OF 2016 MUNICIPAL BUDGET

Deputy Mayor Dinneen offered the 2016 Municipal Budget forward for introduction by the Township Committee. Deputy Mayor Dinneen stated that the 2016 Budget reduces overall township spending for the third consecutive year while maintaining essential services, and some cases, expanding services. In addition this budget allows the Township to continue to build our surplus, which is critical when managing our finances responsibly. Additionally this budget allows for the expansion of the Township Police Department while improving our infrastructure through the building of a Public Safety Center, refurbishing our parks and continuing to repave our roadways. Through the entire Committee our hard work we have held the overall tax rate increase to approximately 1% - or only \$18 per average assessed household. However, we can control spending and investments, and we're proud of the continued progress we've made in introducing this year's budget.

In addition, the township has also committed to better assist with vehicle maintenance, fuel and inclusive insurance coverage. We've already seen the positive effects of the improvements at the squad in response times, recruitment, and the overall relationship with the town in recent months. Committeeman Mansdoerfer echoed the Deputy Mayor remarks.
