

**TOWNSHIP OF LUMBERTON
RESOLUTION 2015-09-181**

**SHARED SERVICES AGREEMENT WITH BURLINGTON COUNTY DEPARTMENT OF
PUBLIC SAFETY, DIVISION OF CENTRAL COMMUNICATIONS**

WHEREAS, the Burlington County Board of Chosen Freeholders (hereinafter the “Board”) recognizes the need to provide the residents of the County and its various townships with appropriate cost savings measures and opportunities for the benefit of all residents of the County; and

WHEREAS, a number of municipalities, townships and boroughs within the County (hereinafter “Entity” or Entities”) have requested that Burlington County, through the Burlington County Department of Public Safety, Division of Central Communications, allow for routing of Central Communications and “911” calls through the Burlington County Office of Emergency Management which services are paid for and administered by Burlington County; and

WHEREAS, the County and the entity would maintain the mutual responsibilities as detailed in the attached Shared Services Agreement between the parties for the period of August 1, 2015 through July 31, 2020; and

WHEREAS, the County and Lumberton Township are authorized by the “Shared Services Act” N.J.S. 40A-65-4 et seq., to enter into any contract with joint provision of any service which any party to the agreement is authorized to render within its own jurisdiction; and

WHEREAS, the parties have agreed to participate as documented in the attached Shared Services Agreement between the County of Burlington and the Township of Lumberton establishing the respective rights of and obligations of the parties regarding this Shared Services Agreement.

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Lumberton, County of Burlington, State of New Jersey that:

- The attached Shared Services Agreement between Burlington County Department of Public Safety, Division of Central Communications and Lumberton Township for utilization of the Burlington County Department of Public Safety, Division of Central Communications/911 call service shall be effective for the period of August 1, 2015 through July 31, 2020.
- The Lumberton Township Municipal Clerk and Chief of Police are hereby authorized to sign, seal, execute and witness/attest the Agreement on behalf of Lumberton Township.
- The Lumberton Township Municipal Clerk and Chief of Police are authorized to take any action necessary to implement the terms of the Shared Services Agreement.

- The term of the Agreement shall be for a period of three (3) years commencing August 1, 2015 and terminating July 31, 2020.
- All terms, conditions and responsibilities between the parties as detailed in the attached Shared Services Agreement shall remain in full force and effect.




