BE IT FINALLY RESOLVED, that the governing body of the Township of Lumberton pursuant to N.J.A.C. 5:30-5,5(b), the certification of available funds, shall either certify the full maximum amount against the budget at the time the contract is awarded, or no contract amount shall be chargeable or certified until such time as the goods or services are ordered or otherwise called for prior to placing the order, and a certification of availability of funds is made by the Chief Finance Officer.
