## RESOLUTION OF THE TOWNSHIP OF LUMBERTON APPOINTING AN MUNICIPAL CLERK AND REGISTRAR OF VITAL STATISTICS

**WHEREAS**, a vacancy exists in the position of Municipal Clerk for the Township of Lumberton due to the resignation of Stephanie Yurko on February 9, 2016; and

WHEREAS, Brandon E. Umba was appointed to serve as the acting Municipal Clerk on April 18<sup>th</sup>, 2016 until such time that the Township of Lumberton hires a fully licensed Registered Municipal Clerk to fill the vacancy; and

WHEREAS, the Township Committee of the Township of Lumberton has completed an exhaustive and thorough search for a licensed Registered Municipal Clerk and Certified Municipal Registrar of Vital Statistics and has conducted several interviews of qualified candidates; and

WHEREAS, Debra L. Shaw-Blemings, RMC, CMR, a resident of Waterford Township who is fully licensed by the State of New Jersey, Department of Community Affairs, as a Registered Municipal Clerk and Certified Municipal Registrar of Vital Statistics, has been selected by the Township Committee to serve as the Municipal Clerk and Registrar of Vital Statistics of the Township of Lumberton for a three year term as required by New Jersey Statute effective August 15<sup>th</sup>, 2016; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Lumberton, County of Burlington, and State of New Jersey as follows:

- 1. Effective August 15<sup>th</sup>, 2016, Debra L. Shaw-Blemings, RMC, CMR is hereby appointed Municipal Clerk and Registrar of Vital Statistics as promulgated by N.J.S.A. 40A:9-133;
- 2. The salary for the Municipal Clerk position to be paid to Debra L. Shaw-Blemings, RMC, CMR shall be \$63,000.00 per annum based on a 35 hour work week, in addition to the \$1,800 per annum which shall be paid for serving in the position of Registrar of Vital Statistics.
- 3. This Resolution shall take effect August 15<sup>th</sup>, 2016.

**BE IT FURTHER RESOLVED,** that a copy of this resolution be forwarded to the Township Solicitor (George Morris, Parker McCay) Township auditor (Bowman & Company) and the Division of Local Government Services.
