## RESOLUTION OF THE TOWNSHIP OF LUMBERTON AUTHORIZING PAYMENT NO. 3 FOR THE CONTRACT WITH THOR CONSTRUCTION GROUP, LLC FOR THE VILLAGE GREEN PARK IMPROVEMENT PROJECT, PHASE 2

WHEREAS, the Township of Lumberton awarded a contract to Thor Construction Group, LLC, a New Jersey Corporation having its principal place of business at 39 Girard Ave., West Long Branch, NJ 07764; and

**WHEREAS**, the Township Committee by Resolution No. 2015-08-168 dated August 25, 2015 awarded a contract of a total amount of \$143,230.00 to Thor Construction Group for Village Green Park Improvements Phase 2; and

WHEREAS, the Township Committee by Resolution No. 2015-09-182 dated September 22, 2015 awarded a Change Order to said contract of an amount of \$28,546.00 for a total project amount of \$171,776.00 to Thor Construction Group, LLC for Village Green Park Improvements Phase 2; and

WHEREAS, the Township Committee by Resolution No. 2016-137 dated July 26, 2016 awarded a Change Order to said contract decreasing the total change order amount from \$28,546.00 to \$26,206.00 for a total project cost of \$169,436.00 to Thor Construction Group, LLC for Village Green Park Improvements Phase 2; and

WHEREAS, the Township's Engineer, Pennoni Associates Inc. has determined that the work contained within this application of payment is complete; and

WHEREAS, Payment No. 3 of \$5,838.72 should be paid; and

**WHEREAS**, the Township's Engineer, Pennoni Associates Inc. recommends that Payment No. 3 be made in accordance with N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, sufficient Funds are available; and

WHEREAS the Township Committee concurs in the forgoing.

**NOW THEREFORE IT BE RESOLVED** by the Mayor and Township Committee of the Township of Lumberton that Payment No. 3 to Thor Construction Group LLC. in the amount of \$5,838.72 is hereby approved and the Township Committee further authorizes the Township Administrator to execute said payment with funds certified by the Chief Financial Officer on this 26<sup>th</sup> day of July, 2016.
