**RESOLUTION OF THE TOWNSHIP OF LUMBERTON AUTHORIZING CHANGE ORDER  
NO. 1 TO AMEND CONTRACT WITH THOR CONSTRUCTION GROUP THE  
TURNBRIDGE DRIVE /WESTMINSTER DRIVE PLAYGROUND IMPROVEMENT PROJECT**

**WHEREAS**, the Township of Lumberton awarded a contract Thor Construction Group, a New Jersey Corporation having its principal place of business at 39 Girard Ave West Long Branch, NJ 07764; and

**WHEREAS**, the Township Committee by Resolution No. 2016-125 dated June 28, 2016 awarded a contract of a total amount of \$130,102.50 to Thor Construction Group for Turnbridge Drive/Westminster Drive Playground Improvement Project; and

**WHEREAS**, the Township's Engineer, Pennoni Associates determined that an increase in needed to fund a 5' wide concrete sidewalk for ADA Accessibility for the playground project is needed in the original bid; and

**WHEREAS**, the cost increase for this contract amounts to \$14,000.00; and

**WHEREAS**, the Township's Engineer, Pennoni Associates recommends the following Change Order No. 1 pursuant to the Local Public Contract Law Application of N.J.A.C. 5:30-11.1 et seq., as being necessary and beneficial; and

**WHEREAS**, the Township Committee concurs in the forgoing.

**NOW THEREFORE IT BE RESOLVED** by the Mayor and Township Committee of the Township of Lumberton that Change Order No. 1 with Thor Construction Group, increasing the total change order amount by \$14,000.00 for a total project cost of \$144,102.50 is hereby approved and the Township Committee further authorizes the Township Administrator to execute said Change Order on this 6<sup>th</sup> day of September, 2016.
