**RESOLUTION AUTHORIZING THE AWARD OF A BID AND EXECUTION OF A CONTRACT  
BETWEEN THE TOWNSHIP OF LUMBERTON AND ARAWAK PAVING, CO., INC.  
FOR THE MAPLE GROVE BOULEVARD IMPROVEMENTS PROJECT**

**WHEREAS**, the Township of Lumberton, through its Engineer, Environmental Resolutions, Inc., solicited bids for the Maple Grove Boulevard Improvements Project; and

**WHEREAS**, on July 20, 2016 at 10:00am, the Township received four bids as follows:

Vendor	Base
Arawak Paving Co., Inc. (Hammonton)	\$165,900.00
American Asphalt (West Collingwood)	\$173,346.00
Jerry & Sons Excavation	\$199,976.00

**WHEREAS**, the Township Committee of the Township of Lumberton wishes to authorize the award of the Base bid for the Maple Grove Boulevard Improvement Project, submitted on July 20, 2016, by Arawak Paving Company, Inc., 7503 Weymouth Road, Hammonton, NJ 08037; and

**WHEREAS**, the Engineer reviewed the bids and confirmed that the low vendor possessed the proper licenses, insurance, qualifications and Bid Bond and copies of the same have been provided to the Township and confirmed through communications with references; and

**WHEREAS**, the Engineer recommends award to the low vendor Arawak Paving Company, Inc.; and

**WHEREAS**, the Chief Financial Officer certifies that funds are available for the award of this bid to the lowest vendor;

**MAY IT BE FURTHER RESOLVED**, the above is condition of award; Due to the current shutdown of all New Jersey Department of Transportation (NJDOT) projects funded by the Transportation Trust Fund, no work can begin on Maple Grove Boulevard until authorized by NJDOT, as per the Governor's executive order. The Maple Grove Boulevard portion of the 2016 Lumberton Township Road Improvement Program is funded in part by a NJDOT FY 2016 Municipal Aid Grant.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Lumberton as follows:

1. The contract for the Maple Grove Boulevard Improvement Project is awarded to Arawak Paving Company, Inc. in the amount of One Hundred and Sixty Five Thousand, Nine Hundred Dollars (\$165,900.00) (Base Bid).
2. A copy of this Resolution shall be provided to Arawak Paving Co., Inc. and Environmental Resolutions, Inc.
3. Due to the current shutdown of all New Jersey Department of Transportation (NJDOT) projects funded by the Transportation Trust Fund, no work can begin on Maple Grove Boulevard until authorized by NJDOT, as per the Governor's executive order. The Maple Grove Boulevard portion of the 2016 Lumberton Township Road Improvement Program is funded in part by a NJDOT FY 2016 Municipal Aid Grant.


