**RESOLUTION OF THE TOWNSHIP OF LUMBERTON AUTHORIZING PAYMENT NO. 3-FINAL
FOR THE CONTRACT WITH JERRY AND SONS INC. FOR ALLSPICE WAY PHASE 2 /
INTERSECTION IMPROVEMENTS PROJECT**

WHEREAS, the Township of Lumberton awarded a contract to Jerry & Sons Inc., a New Jersey Corporation having its principal place of business at 5981 Scranton Ave., Mays Landing, NJ 08330; and

WHEREAS, the Township Committee by Resolution No. 2016-058 dated February 9, 2016 awarded a contract of a total amount of \$276,854.00 which included a base amount of \$229,381.00 and Add Alternate #1 amount of \$47,473.00 to Jerry & Sons Inc., for Allspice Way Phase 2/ Intersection Improvements Project; and

WHEREAS, the Township Committee by Resolution #2016-145 dated July 26, 2016 authorized Change Order No. 1 with Jerry & Sons Inc., decreasing the project cost by \$5,000.00 for a total contract; and

WHEREAS, the Township's Engineer, Pennoni Associates has determined that the work contained within this application of payment is complete; and

WHEREAS, Payment No. 3 of \$5,437.08 should be paid; and

WHEREAS, the Township's Engineer, Pennoni Associates recommends that Payment No. 3 -Final be made in accordance with N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, sufficient Funds are available; and

WHEREAS, the Township Committee concurs in the forgoing.


