**RESOLUTION OF THE TOWNSHIP OF LUMBERTON AUTHORIZING CHANGE ORDER NO. 2  
FOR THE CONTRACT WITH ARAWAK PAVING COMPANY, INC. FOR THE  
NEWBOLDS CORNER ROAD RECONSTRUCTION AND OVERLAY PROJECT**

**WHEREAS**, the Township of Lumberton, through its Engineer, Pennoni Associates, Inc., solicited bids for the Newbolds Corner Road Reconstruction and Overlay Project; and

**WHEREAS**, the Township Committee by Resolution No. 2016-156 dated August 19, 2016 awarded a contract of a base bid amount of \$157,900.00 to Arawak Paving Co., Inc. of 7503 Weymouth Road, Hammonton, NJ 08037 for the Newbolds Corner Road Reconstruction and Overlay Project; and

**WHEREAS**, the Township Committee by Resolution No. 2016-175 dated September 27, 2016 awarded Payment No. 1 to said contract of an amount of \$134,525.97; and

**WHEREAS**, the Township's Engineer, Pennoni Associates determined that a reduction is needed in the original bid due to an adjustment of contract quantities to those actually constructed for the road reconstruction and overlay project; and

**WHEREAS**, the cost reduction for this contract amounts to \$2,134.27 decreasing the total project cost to \$155,765.73; and

**NOW THEREFORE IT BE RESOLVED** by the Mayor and Township Committee of the Township of Lumberton that Change Order No. 2 to Arawak Paving Co., Inc. for the contract reduction amount of \$2,134.27 is hereby approved and the Township Committee further authorizes the Township Administrator to execute said change order on this 22<sup>nd</sup> day of November, 2016.


