**RESOLUTION OF THE TOWNSHIP OF LUMBERTON AUTHORIZING PAYMENT NO. 2  
FOR THE CONTRACT WITH ARAWAK PAVING COMPANY, INC. FOR THE  
NEWBOLDS CORNER ROAD RECONSTRUCTION AND OVERLAY PROJECT**

**WHEREAS**, the Township of Lumberton, through its Engineer, Pennoni Associates, Inc., solicited bids for the Newbolds Corner Road Reconstruction and Overlay Project; and

**WHEREAS**, the Township Committee by Resolution No. 2016-156 dated August 19, 2016 awarded a contract of a base bid amount of \$157,900.00 to Arawak Paving Co., Inc. of 7503 Weymouth Road, Hammonton, NJ 08037 for the Newbolds Corner Road Reconstruction and Overlay Project; and

**WHEREAS**, the Township Committee by Resolution No. 2016-175 dated September 27, 2016 awarded Payment No. 1 to said contract of an amount of \$134,525.97; and

**WHEREAS**, the Township Committee by Resolution No. 2016-200 dated November 22, 2016 awarded Change Order No. 1 reducing said contract in the amount of to \$2,134.27 decreasing the total project cost to \$155,765.73; and

**WHEREAS**, the Township's Engineer, Pennoni Associates has determined that the work contained within this application of payment is complete; and

**WHEREAS**, the Township's Engineer, Pennoni Associates recommends that Payment No. 2 for the amount of \$21,239.75 be made in accordance with N.J.S.A. 40A:11-1 et seq.; and

**WHEREAS**, sufficient Funds are available; and

**NOW THEREFORE IT BE RESOLVED** by the Mayor and Township Committee of the Township of Lumberton that Payment No. 2 to Arawak Paving Co., Inc. in the amount of \$21,239.75 is hereby approved and the Township Committee further authorizes the Township Administrator to execute said payment with funds certified by the Chief Financial Officer on this 22<sup>nd</sup> day of November, 2016.

**BE IT FURTHER RESOLVED** that a copy of this Resolution shall be provided to Arawak Paving Company, Environmental Resolutions, Inc., Township CFO, Township QPA and Township Administrator.
