**EMERGENCY TEMPORARY BUDGET APPROPRIATIONS  
DUE TO EXTENSION OF BUDGET DEADLINES**

**WHEREAS**, section 40A:4-19 of the Revised Statutes of the State of New Jersey provides that (where any contracts or payments are to be made prior to the final adoption of the 2014 Budget) temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

**WHEREAS**, the Director of Local Government Services has extended the statutory budget adoption date until April 25th 2014; and

**WHEREAS**, the temporary budget previously adopted in January 2014 only allows for appropriations through the end of the first quarter; and

**WHEREAS**, the total emergency temporary resolutions adopted in the year 2014 pursuant to the provisions of Chapter 96, P.L. 1951 (N.J.S.A. 40A:4-20) INCLUDING THIS RESOLUTION TOTAL \$771,948.00
