**RESOLUTION AUTHORIZING THE RENEWAL OF THE INTERLOCAL SERVICE**  
**AGREEMENT ALLOWING THE TOWNSHIP OF LUMBERTON TO ENTER INTO AN**  
**INTERLOCAL SERVICE AGREEMENT WITH THE "Collision Investigation and Traffic**  
**Enforcement Unit (C.I.T.E. Unit)" FOR 2014**

**WHEREAS**, the Townships of Lumberton, Mount Holly, Eastampton, and Westampton are neighboring municipalities within the County of Burlington; and

**WHEREAS**, their Police Departments provide traffic enforcement and crash investigation in their respective municipalities; and

**WHEREAS**, the municipalities often rely upon each other for additional specially trained officers to provide such services as investigations and reconstructions of serious motor vehicle crashes, and

**WHEREAS**, the Townships wish to enter into an Interlocal Service Agreement continuing into 2014 to utilize overtime, comp time, or shift swaps to enforce traffic laws including and not limited to driving while intoxicated and to investigate serious motor vehicle crashes within the municipalities; and

**WHEREAS**, said Interlocal Service Agreement has been prepared by the Township of Lumberton and has been found to be acceptable by the Township Committee of the Township of Lumberton; and

**WHEREAS**, N.J.S.A. 40:8A-1, et seq., the Interlocal Service Act, permits this Interlocal Service Agreement.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Lumberton, County of Burlington, State of New Jersey, that the Mayor of the Township of Lumberton is hereby authorized to execute the Interlocal Service Agreement with the Townships of Lumberton, Mount Holly, Eastampton, and Westampton concerning the C.I.T.E. Unit; and

**BE IT FURTHER RESOLVED** that the participation of the Lumberton Township Police Department is authorized for a period not to exceed six months from December 1, 2013; and


