THE STATE OF NEW JERSEY MANDATES ALL DOGS MUST HAVE CURRENT RABIES VACCINATIONS PURSUANT TO N.J.S.A. 4:19-15.1 et seq. ALL MUNICIPALITIES ARE REQUIRED TO MONITOR SUCH BY THE LICENSING OF DOGS THEREFORE EVERY DOG OWNER IN LUMBERTON TOWNSHIP MUST LICENSE THEIR PET THIS YEAR AND EVERY YEAR WITHOUT EXCEPTION. FAILURE TO LICENSE YOUR DOG MAY RESULT IN SUMMONS BEING ISSUED AND COURT FINES ASSESSED.

2022 DOG LICENSES are due for renewal after JANUARY 1ST prior to JANUARY 31ST of each year (to avoid a late fee) and may be obtained at the Township Clerk's Office weekdays between the hours of 8:00 a.m. and 4:00 p.m. For your information, Municipal Offices will be closed on Monday, January 3, 2022, in observance of New Year's Day and will reopen on Tuesday, January 4, 2022, at 8:00 a.m. *License Fee may be paid by check (payable to Lumberton Township) or by cash only (no debit /credit cards/Venmo, etc. accepted).*

For your convenience, the application form below may be used to obtain your license by mail. If you choose to use this mail-in application, ENCLOSE A SELF-ADDRESSED STAMPED RETURN ENVELOPE along with your check payable to the Lumberton Township and a copy of the current rabies certificate.

Dog License Fees are as follows:

Spayed/Neutered \$13.00 ~ or ~ Non-Spayed/Neutered \$16.00
"Late Fee" of \$5 will be assessed to any application received after 1/31/2022

IF YOU HAD A DOG LICENSED IN LUMBERTON TOWNSHIP IN 2021 AND NO LONGER HAVE THE DOG, PLEASE CONTACT THE TOWNSHIP CLERK'S OFFICE AT (609) 267-3217 TO UPDATE OUR DATABASE IN ORDER TO AVOID FURTHER NOTICES OR FINES.

Pursuant to NJSA 4:19-15.1 et seq., the Rabies Vaccination Certificate must be valid thru October 30, 2022, or you must obtain a rabies booster shot and new vaccination certificate in order to purchase a license for year 2022. Any expiring rabies vaccination certificates must be renewed within 30 days of the expiration date in order to qualify for waiver of late fee. Also, according to Lumberton Township Code 136-8k, there is a limitation to ownership or custodianship of no more than four (4) dogs per household.
