

### Applying for a Marriage License in Lumberton Township

- Completed application to be emailed to the Deputy Registrar, Desiree Buck, to review and advise of any changes and/or missing information needed prior to the applicants & witness coming into the office.
  - o deputyclerk@lumbertontwp.com
- Appointment REQUIRED appointment will be made after Ms. Buck receives and reviews
  your application via email.
  - Appointments are scheduled Monday through Friday between 8:30am and 3:30pm
  - Appointment will be approximately 15 minutes
- At least one applicant must reside in Lumberton Township (photo ID reflecting same) in order to apply in Lumberton Township OR both applicants live out of state and will be getting married in Lumberton Township.
- Following Information Required at Time of Application:
  - Completed Marriage Application (Signature Section to be completed at time of appearing before the Registrar/Deputy Registrar).
  - VALID Government issued photo ID showing name and current address required for both applicants and the witness 18 years of age or older
  - Cost of license is \$28.00 and is due at the time of application (cash or check only)
- You may apply for your license as early as 6 months before the wedding date.
- There is a 72-hour waiting period once the application is complete/filed with our office until the license can be issued.
